## WHAT IS RAGGING?

The Hon'ble Supreme Court of India has given a comprehensive meaning of ragging as under: **“Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing , treating or handling with rudeness to any student , indulging in rowdy or undisciplined activities which cause or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student.”**

## FORMS OF RAGGING

It is said that man's imagination knows no bounds. Very true, but when it comes to ragging, it can be rightly said that man's perverted imagination too knows no bounds! From what was intended to provide good humor and harmless fun to students, ragging today had assumed torturous, vulgar and inhuman forms that defy all norms of decency, humanity and morality which can't be allowed to reappear under any circumstances. Some of the most popular forms of ragging in colleges are:

Ø **Dress Code Ragging:** The freshers are asked to dress in a specific dress code for a particular period of time. But this isn't as easy as it seems. For the dress code prescribed is generally weird e.g. dressing totally in white or black with the hair oiled and combed in a particular style.

- Ø The dress code ragging may make the freshers feel awkward and uncomfortable as it often brings them unnecessary attention from everybody
- Ø **Formal Introduction:** This involves asking the freshers to introduce themselves in 'Shuddh Hindi'. The introduction includes the fresher's name, address, school, marks, etc.
- Ø **Verbal Torture:** Verbal torture involves indulging in loose talks. The freshers may be asked to sing the lyrics of any vulgar song or use abusive language while talking to the seniors.
- Ø **Sexual Abuse:** This is the severest form of ragging that takes place in colleges. The seniors are mainly interested in 'juicy' details such as the anatomical description of one's body parts, his or her sexual interests, etc. In many cases, the freshers have been asked to strip before the seniors.
- Ø **Playing The Fool:** The freshers may be asked to enact scenes from a particular movie or mimic a particular film star. In many cases, the seniors may also ask the freshers to do silly things like climbing a tree, kissing a tree, proposing to someone from the opposite sex, etc.
- Ø **Hostel Ragging:** Outstation students who stay in the hostel are most vulnerable to ragging. They may be asked to do all odd acts from cleaning the room of seniors to washing their clothes, from fetching them water or milk to completing their assignments.
- Ø **Drug Abuse:** This can be the worst form of ragging wherein the freshers are forced to try drugs thereby driving them into addiction.

## **PUNISHMENTS / STRINGENT ACTIONS IN CASE OF RAGGING**

- Ø Depending upon the nature and gravity of the offence as established, the possible punishments for those found guilty of ragging at the Institution level shall be anyone or any combination of the following: -
- Ø Cancellation of admission
- Ø Suspension from attending classes
- Ø Withholding / Withdrawing Scholarship / Fellowship and/or any other benefits

- ∅ Debarring from appearing for any test / examination and/or other evaluation process
- ∅ Withholding results of any test / examination
- ∅ Debarring from representing the Institute in any campus interview
- ∅ Debarring from representing the Institute from attending/ participating in any national or international meet/tournament / youth festival, etc.
- ∅ **Suspension / Expulsion from the hostel**
- ∅ **Rustication from the Institute for such period as decided by concerned authorities**
- ∅ Expulsion from the Institute and consequent debarring from admission to any other educational institution, for such period as may be decided by concerned authorities
- ∅ Imposition of fine up to Rs. 25,000/- (Rupees Twenty-Five Thousand)
- ∅ Rigorous imprisonment up to 3 (three) years (by a Court of Law) etc.

**Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.**

## INTERNAL COMPLAINTS COMMITTEE (ICC)

### *(Sexual Harassment of Women Employees and Students at Workplace-Prevention, Prohibition and Redressal)*

The KIET Group of Institutions has zero tolerance against sexual harassment.

#### ***Sexual Harassment meaning-***

An unwanted conduct with sexual undertones which is persistent and which demeans, humiliates or creates a hostile and intimidating environment or is calculated to induce submission by actual or threatened adverse consequences and includes any one or more or all of the following unwelcome acts or behavior (whether directly or by implication), namely: -

- (a) Any unwelcome physical, verbal or non-verbal conduct of sexual nature
- (b) Demand or request for sexual favors
- (c) Making sexually colored remarks
- (d) Showing pornography
- (e) Any comment or post on social media platforms like WhatsApp, Face book, Twitter...etc.which implies detrimental treatment to the person.

#### ***Punishment***

Any student found guilty of sexual harassment shall be punished in accordance depending upon the severity of the offence. The Institute may: -

- (a) Withhold privileges of the student such as access to the library, auditorium, hostel, transportation, scholarships, allowances and identity card.
- (b) Suspend or restrict entry into the campus for a specific period.
- (c) Suspension/Expulsion from the hostel
- (d) Expel and strike off name from the rolls of the institution, including denial of readmission, if the offence so warrants.
- (e) Award reformatory punishment like mandatory counseling and or performance of community services.

**Action against frivolous complaint:-** If the allegations were false, malicious or forged/misleading, the complainant shall be liable to be punished as per the Institute policy/punishment regulation.

## DISCIPLINARY INSTRUCTIONS

1. Every student must **carry his/her Identity Card** issued by the institute in the KIET premises, failing which it will be treated as an indiscipline act.
2. It is mandatory for the students to attend the classes, laboratory sessions, tutorial, etc... on all working days from the start to the end of the term / semester.
3. Students are expected to behave in a responsible manner and abstain from chatting amongst themselves while the class is in progress.
4. Any indiscipline or misbehavior in class or in the campus or in the bus or even outside the campus would warrant disciplinary action against the student(s).
5. Students are encouraged to spend their free time in the Library/Reading Room. Clustering in the verandahs or crowding in front of the offices or the Campus roads are to be avoided.
6. No student shall indulge in any activity that might be illegal or may lead to disorderliness.
7. Possession or consumption of narcotic drugs, tobacco, smoking cigarettes, alcohol and other intoxicating substances are strictly prohibited in the campus and hostels.
8. Students should follow institute dress code as per the institute guidelines.
9. Any reported, observed, objectionable conduct within or outside the premises of the Institute, will make him / her liable for strict disciplinary action.
10. Students shall not indulge in activities, which would damage / disfigure Institute's property including books, apparatus, furniture etc.
11. Students involving in business, collection of funds, compelling others to join in some organization as a member etc must not be made under any circumstances.
12. No one shall indulge in politics, violence, rioting or instigate communal feelings or have dealings with outside elements. Such activities may lead to expulsion of the student from the hostel as well as from the Institute.
13. Misconduct or infringement of rules & regulations and activities which are not in the interest of the institution and harmful to the reputation of the institution will make a student liable for severe disciplinary action and even expulsion from the hostel as well as from the Institute.
14. The institute has full power to suspend, fine, rusticate or to take any action which is necessary in case of any indiscipline by the student.
15. Students need to obtain prior permission from the college authorities to exhibit any type of banners, flags, boards etc. inside the campus, hostels, gates, buildings or on the compound walls.

## INDISCIPLINE SHALL INCLUDE

1. **Not carrying the institute identity card.**
2. Staying away from classes without any valid reason.
3. **Staying in hostels during academic hours** without any valid reason.
4. Disrespectful behavior towards the faculty/staff.
5. Provoking students to abstain from classes and participating in strikes in the institute.
6. Walking around verandah during free hours and creating disturbance to the classes (During free hours the students are expected to make use of the library or go to the reading room).
7. Disorderly behavior in the class.
8. Organizing tours without the permission of the Director.
9. Organizing meetings in the college institute or displaying notices on the institute notice board without the permission of the Director.
10. Bringing outsiders unnecessarily into the institute campus.
11. Distributing leaflets, hand-bills or other printed materials and displaying banners/posters inside the campus.
12. Scribbling offensive, abusive obscene words or figures on black boards, or any kind of writing on the wall or other places in the institute.
13. Holding meetings on political/religious basis.
14. Smoking, consumption of alcoholic beverages and use of narcotic drugs are strictly prohibited. Criminal proceedings will be taken against those found under the influence of alcohol or narcotic drugs within the campus/ hostel.
15. Vandalism and destruction of institute property will be severely dealt with and material loss will be fully recovered with fine.
16. Fighting / using abusing language with other students.

***NOTE: The above rules are liable to be amended when found necessary. In any indiscipline act, victim student should contact to any member of Institute Proctorial Board.***

## DRESS CODE FOR THE STUDENTS

1. All students are required to follow the dress code from Academic session 2018-2019 as illustrated below:
  - (a) **Academic Area:** Full Pant, Shirt / T-Shirt, Jeans, long Kurta / Kurti with legging / formal pant, Salwar Kameej and all formals are allowed.
  - (b) **Labs/workshops:** The uniform stipulated by the concerned department must be worn for all lab and workshop classes.
  - (c) **Playing Area:** Sportswear as per activities is allowed.

- (d) **Other Areas:** Vulgar dress not permitted in common area/ social gathering. Night dress permitted within the premises of hostel only.
- (e) Display of profane/ bad language / promoting use of drugs, Alcohol or Tobacco in any form embossed on the dress is not permitted.
- (f) **Footwear:** Both shoes and sandals / formal belly are allowed but bathroom slippers will not be permitted in classrooms, workshops and labs.
2. In case of violation of dress code, the students concerned will be asked by the concerned faculty / coordinators / HoD/ Deans / Director to leave the academic areas.
3. In the event of repeated violation of the prescribed dress code strict disciplinary action may be initiated against the defaulter.

**Note: Every student is expected to maintain the sanctity of the academic Institute in the truest tradition.**

## GUIDELINES FOR HOSTEL STUDENTS

A new student, on arrival, will report to the Hostel Warden/Rector who will allot him/her a room/seat in one of the Hostels after the student has paid fees and got registered. The following are the Standing Orders for compliance by all Hostellers:

1. At the time of occupying the room, student must check the room furniture, fixtures, electrical fittings etc. and sign receipt. He/she will be charged for any loss, damage done to furniture, fixture, fittings and articles issued to him/her along with the disciplinary action if warranted. Sketching/painting on walls is prohibited. Rooms once allocated are not to be changed without the written permission of Competent Authority.
2. Students themselves are responsible for all their belongings. They must ensure all their valuables including laptops are **properly locked** and not left outside even for short period. They are advised to use good quality locks.
3. Students must show their hostel ID card to the security staff every time they enter/leave Hostel gate.
4. Hostellers are required to compulsorily get their rooms cleaned by the house keeping.
5. **Smoking, consumption/possession of liquor, intoxicants, drugs, cigarettes, hookah etc inside or outside the Campus is strictly prohibited.** Any violation will invoke severe penalty including rustication from the Hostel/ Institute.
6. Hostellers should not indulge in acts such as loud playing of musical instruments or radio or loud singing or dancing etc. which may disturb others at study or work in the Hostels.
7. Students are not permitted to keep fire-arms or any lethal weapon with them in the Hostel premises even though possessing a license for it.
8. Students are prohibited from keeping obscene literature/video films/CDs in their possession. Any violation in this regard will result in severe disciplinary action including rustication the hostel.
9. Electrical appliances like **electric irons, heaters or other electrical appliances are not permitted in hostel rooms.**
10. Students, unless specially permitted, will be allowed to occupy the rooms allotted to them in their hostel only a day prior to commencement of their academic session. Likewise, they must vacate their rooms, within 3 days of the closure of their academic session.
11. Before proceeding on summer vacation, students must hand over the charge of their rooms, the furniture and the fittings etc. to Warden / Rector and get a receipt from him.

12. No student is allowed to engage private servant or keep pets.
13. Visitors including parents are not allowed to go inside the hostel rooms. Parents/Guardians can meet their wards in the Visitor's Room during the specified visiting hours with the permission of Warden.
14. Students can be permitted to visit their Parents, Local guardians, near relatives occasionally. All such visits shall have to be after due permission from the respective HoD.
15. Students are prohibited from giving shelters to any other student / outsider in their rooms. In case of any unauthorized shelter, the student will be liable to disciplinary action. Unauthorized occupation / shelter to any outsider will be reported to local administration for suitable action.
16. All students must be present in their respective hostels as per specified times unless specifically permitted to stay out in the night and for a specific reason in writing by the respective Head of Departments.
17. All students staying in the hostels during summer vacations shall have to abide by the Hostel Rules in vogue.
18. Students are required to observe the mess timings religiously. They will not get entry & food beyond the prescribed timings in the mess.

19. Ragging in any form is unlawful and strictly prohibited. **Student found indulged in ragging may be expelled from the Hostel as well as the Institute.** FIR will also be lodged against student indulging in ragging.
20. Students not returning back to their hostels within the prescribed time without the permission from the Warden may attract disciplinary action. The student may be expelled from the Hostel in case of repeated offences.
21. Students violating any of the above guidelines will face disciplinary action in which case the decision of Director will be final.

## GUIDELINES FOR ATTENDANCE

- (1) Every student has to maintain 100% attendance (minimum 70%) to appeared in all the class tests and pre-semester examinations.
- (2) As per AKTU rules, minimum 75% attendance is required to appeared in end semester University Examination.
- (3) In medical case the students will be allowed to appear in examination with the minimum of 60% attendance.
- (4) **The following criteria for attendance will be followed:**

- Ø Student involved in industrial visit/ Project competition/ Presentation at industry will get 100% attendance of the approved duration (Prior approval of HoD is mandatory).
  - Ø Students involved in guest lecture/seminar/workshop and placement will get 100% attendance for the approved duration. (Prior approval of HoD is mandatory).
  - Ø Student involved in consultancy/ Project at industry, appearing in the examinations like; GATE/CAT/GPET/GRE/SSB (on providing evidence of actual days of leave) will get maximum of 20% attendance of the total attendance.
  - Ø Student involved in participation in Cultural Event/Sports Event (like endeavor/ INNOTECH/ Cultural Event/ RANN/ Sports Fest) will get 10% attendance (with the approval of Dean SW) for the approved duration.
- (5) Attendance in all the lectures, tutorials and laboratory classes are compulsory.
  - (6) Parents of the students (having monthly attendance less than 70%) will be informed by the respective HODs.
  - (7) If any student is absent from classes for more than three consecutive days, he/she shall have to take prior permission of the respective HoD. Please note that without permission, the absenteeism will be treated as serious indiscipline act.
  - (8) Conduct of the students should be exemplary, not only within the KIET premises but also outside the campus to maintain the prestige of Institute. To make KIET best institute, students are expected to adhere to the laid down guidelines and maintain discipline religiously.

## GUIDELINES FOR LIBRARY

1. KIET Library offers a variety of books including text books, reference books, magazines, journals (hard/soft copy) etc.
2. **A maximum of 5 books will be issued to M.Tech., MCA, MBA students, 4 books to B.Tech. students, 6 books to B.Pharma students and 7 books to M.Pharma. students at a time for 15 days.**
3. Book-Bank facility is also available for B.Tech., B.Pharma., MBA and MCA students. One book for each subject will be issued to students for entire semester.
4. An overdue charge of Rs. 2/- will be collected for each day for per book when it is kept over-time.
5. Borrowing facility is only for the members of the library against Q R Coded Identity Card cum library card issued to them by library. Books are issued on counter on presenting the Q R Coded identity card. The library cum identity card is Non-Transferable. In case of misuse of Identity card student will be fined Rs. 200/-.

6. If only a single copy of any book is available in the library, then it will not be issued, the same can only be consulted in the library.
7. The defaulters will not be issued books in future.
8. In the case of loss of book the borrower will have to replace the book along with fine as admissible. If he /she does not replace the book then he/she will have to pay current cost of the book.
9. Loss of ID card should be reported to the Chief Proctor immediately. Duplicate ID card will be issued on payment of Rs. 200/-.
10. Library remains open from 9.00 AM to 9.00 PM. Self Study hall is also open from 9.00 AM to 2.00 midnight.

12. If any student is found indulging in the process of book hiding, stealing, mutilating, this will be treated as indiscipline act and person will be punished accordingly.
13. Misbehaving with library staff will be treated as serious Indiscipline. He/she will be terminated from library membership.

2. **Verification of Document/ attesting any document or a photograph/ application form:** The student can visit **P.A. to Dean Academic** from 02:00 pm to 04:00 pm on all working day.
3. **Query/permission/approval for Cultural/Sports/Activity outside the campus:** Students are advised to visit **Dean (SW) office** from 04:00 to 05:00 pm on all working days.
