

As per the CV Raman Award policy (placed opposite), the eligibility criteria for CV Raman Award are that the Faculty Members contribution in atleast three categories /attributes of CV Raman Award Nomination form is desirable for the consideration of CV Raman Award.

After the detailed securitizing process (verification of all the claimed credentials), Dean R&D Office has found that total 17 faculty members (11 Normal and 06 Research faculty members) are eligible for the CV Raman Award for session 2022-23.

In reference to the privileges and targets given to the Research faculty members as mentioned in their appointment letters, Dean R&D Office propose that 5 Research faculty members out of 6 eligible Research faculty members (having maximum score 197 and minimum score 91) and 6 Normal faculty members out of 11 eligible normal faculty members (having maximum score 134 and minimum score 79) and should be considered for CV Raman Award, Session 2022-23.
